Silkoline[™] Pillow Inserts (Standard)

SCH's Silkoline[™] standard pillow insert features 44.5 ounces of premium, hypoallergenic, downalternative fill constructed from select microfiber deniers processed with an exclusive 'siliconized' finish. 

Sturgeon Creek Home -- Manufacturer's Limited Warranty

Sturgeon Creek Home LLC (SCH) warrants standard catalog product for one year from the date of invoice against defects in workmanship when put to ordinary use. The warranty does not cover damage or injury caused by unreasonable or abusive use, failure to provide necessary or reasonable care, but accident, alterations, tampering or negligence.

This Limited Warranty is extended only to the original retail purchaser and is not transferable by the original residential retail purchaser.

After one year, if applicable, this Limited Warranty covers replacement parts and materials only, and the original residential retail purchaser will be responsible for all labor and shipping costs associated with the replacement of parts and materials.

This Limited Warranty does not cover scratches, dents, snags, or other damage to wood flooring, carpet or any other type of flooring or floor covering. If floor protectors are applied by the manufacturer, they may not prevent damage to your flooring or carpet. Please inspect the bottom of the legs of your furniture prior to placement in your home. Avoid sliding the furniture across your flooring and use floor protectors designed to protect your carpet and flooring.

This Limited Warranty does not apply to any product that was sold as a either a floor sample, display model, sold

"as-is" or that was purchased at a going out of business or tent sale, from a liquidator, or on a clearance or close-out.

The manufacturer shall not be liable under any extended or additional warranties offered by any retailer or through a third party.

Frames/Springs—Limited Lifetime Warranty: SCH guarantees frames, seat springs and back springs to be free from defects in materials and workmanship for the normal, useful life of the product under normal household use and conditions.

Cushions/Pillows—Limited Warranty: SCH guarantees all seat cushions, back pillows, and arm pillows to be free from defects and materials and workmanship from the date of purchase under normal household use and conditions to the following time frames:

- All back inserts and arm pillow inserts one (1) year from date of purchase.
- All Posture-Lux (P-Lux) and Luxury Down (Lux-Down) seat cushions Five (5) years from date of purchase.

Cushions will normally soften and lose resiliency with use. Cushions and pillows will conform with normal use and aging. All fiber, fiber and foam combinations, down and down blend fills should be fluffed regularly to retain even distribution of fill materials. If reversible, we suggest turning the seat cushions on regular basis for prolonged life.

Fiber/Fill—one (1) year Limited Warranty: SCH guarantees all construction foam, fiber, padding, and filling materials to be free from defects in materials and workmanship for a period of one (1) year from the date of purchase under normal household use and conditions.

Reclining Mechanisms—Limited Lifetime Warranty: SCH guarantees all motion mechanisms to be free from defects in materials and workmanship for the normal, useful life of the product under normal household use and conditions.

Power Reclining Electrical Motors—Limited Warranty: SCH guarantees all power motion electrical motors to be free from defects in materials and workmanship for a period of five (5) years from the date of purchase under normal household use and conditions.

Power Reclining Electrical Components—Limited Warranty: SCH guarantees all power motion electrical components to be free from defects in materials and workmanship for a period of five (3) years from the date of purchase under normal household use and conditions. This includes all handsets, AC adapters, wired connectors, wiring, and wiring harnesses and transformers.

<u>Cozy Mattress® Sleeper Mechanisms—Limited Warranty</u>: SCH guarantees all Cozy Mattress® sleeper mechanisms to be free from defects in materials and workmanship for a period of five (5) years from the date of purchase under normal household use and conditions.

Cozy Mattress® Sleeper Mattress—Limited Warranty: SCH guarantees all Cozy Mattress® sleeper mattresses to be free from defects in materials and workmanship for a period of five (5) years from the date of purchase under normal household use and conditions.

Model 450 Sleeper Mattress—Limited Warranty: SCH guarantees all 450 model, memory foam and gel sleeper mattresses to be free from defects in materials and workmanship for a period of two (2) years from the date of purchase under normal household use and conditions.

Fabric—one (1) year Limited Warranty: SCH guarantees all fabrics, stitching, seams, and zippers to be free from defects in materials and workmanship and from seam slippage for a period of one (1) year from the date of purchase under normal household use and conditions and prescribed cleaning and maintenance. Fabric damage or failure due or chemical treatments applied by the retailer or consumer, heavy soiling, improper cleaning, spills, cuts, burns or pet damage will void this warranty. Color fastness, fabric shrinkage, fiber migration, pilling, wrinkling, and stretching are not covered under this warranty.

COM Fabrics/COL Leathers: Once a COM/COL cover is inspected and accepted, SCH assumes no responsibilities for the performance, flammability, durability, color fastness, or any other issue after upholstered on an SCH product. SCH reserves the right to refuse any material not suitable for upholstery sent in to be used as COM (Custom's Own Material).

Leather-one (1) year Limited Warranty: SCH only uses top grain, cowhide leathers. SCH guarantees all leathers,

stitching, seams, and zippers to be free from defects in materials and workmanship and from splits and tears for a period of one (1) year from the date of purchase under normal household use and conditions and prescribed cleaning and maintenance. Natural markings, wrinkling, stretching, variations in grain or color or fading from heat, light, or sun exposure, all of which occur naturally and are not covered by this warranty. Leather damage or failure due or chemical treatments applied by the retailer or consumer, heavy soiling, improper cleaning, spills, cuts, burns or pet damage will void this warranty. Color fastness, fabric shrinkage, fiber migration, pilling, wrinkling, and stretching are not covered under this warranty.

Remaining Components Parts and Finishes—one (1) year Limited Warranty: SCH guarantees all products not specifically listed in the above warranties to be free of defects in material and workmanship for a period of one (1) year from the date of purchase under normal household use and conditions. This includes but not limited to all finishes, legs, decorative nailhead trim and castors.

Warranty Service: For a period of one year after the date of purchase to the original residential retail purchaser, the Manufacturer will either repair for replace (at its option) any product that has a defect in materials or workmanship covered by this Limited Warranty without charge. To obtain service under this Limited Warranty, you must contact the original furniture retailer from whom you purchased the product and provide proof of original purchase. If required, the retailer will contact the manufacturer to obtain service. The original residential retail purchaser is responsible for delivery to and from the retailer. After one (1) year from the date of purchase, the original retail purchaser will be responsible for all labor and shipping associated with the repair or replacement of the parts and materials.

CAUTION All motion furniture, including recliners, reclining sofas, love seats, sectionals and sleeper sofas have many moving parts. Caution must be used in operations such as reclining, opening, closing, etc. Children should not be allowed to play on or operate motion or sleeper furniture. Always keep hands and feet clear of mechanisms. Only the occupant should operate them.
